APPLICABILITY

Domestic Use

Applicable to a single-family residential dwelling unit and associated building incidental to the residence (where such building is not used for commercial purposes and the residential and corresponding load does not exceed fifty (50) kW in demand), with service supplied through one (1) meter. A residence in which four (4) sleeping rooms or more are rented or are available for rent or lease is considered non-domestic, and the General Service Small schedule will apply. This schedule is not applicable for residential use where such use is primarily for commercial, professional, or any other gainful enterprise other than ordinary farm use.

Ordinary Farm Use

Available for ordinary farm use when all use is supplied through the domestic use meter. Ordinary farm use is defined as normal farming activities and production for one's own use and does not include production or processing for commercial purposes.

TYPE OF SERVICE

Single or multi-phase, sixty (60) cycles, at available secondary voltages.

ELECTRIC SPACE HEATING

Consumers will be required to install separate metering equipment for all approved permanently installed electric space heating and optional water heating. Monthly kWh recorded by the separate metering equipment will be billed at the rate of \$0.07937 per kWh effective January 1, 2022, \$0.07760 per kWh effective January 1, 2023, and \$0.07716 effective January 1, 2024; and will be subject to the power cost adjustment during the winter billing period. The winter billing period shall be November through May. To qualify for the discount noted above, electric heat must be a primary source of heat.

THIS SECTION IS FROZEN: Consumers, whose approved permanently installed electric space heating and water heating equipment was connected prior to April 1, 2018 and where such equipment was not separately metered, will receive a monthly credit of \$0.0250 per kWh for usage above 1,000 kWh during the winter billing period only. However, the credit shall not apply to more than 3,500 kWh per month.

POWER COST ADJUSTMENT AND PROPERTY TAX RIDER

The energy usage is subject to the Power Cost Adjustment and Property Tax Rider clauses.

DEMAND

The demand shall be the maximum average kW load used by the Consumer for any period of fifteen (15) consecutive minutes during the month for which the bill is rendered, as directed or recorded by the Cooperative's demand meter.

MINIMUM BILL

The minimum monthly bill shall be the applicable Service Access Charge and any other charges as provided in the Electric Service Agreement.

TERMS OF PAYMENT

Payment shall be in accordance with the Rules and Regulations of the Cooperative as they currently exist or may be amended from time to time.
