**IDLE SERVICE**

AVAILABILITY

Service that has been disconnected for a period longer than one (1) year.

CONDITIONS OF SERVICE

Any service that has been disconnected for a period longer than one (1) year will be classified as abandoned and is considered idle service.

At the discretion of the Cooperative, a letter will be mailed to the property owner that an idle service(s) is located on their property. The property owner is given the option to either keep or remove the idle service. If no response is received within sixty (60) days of notice, the idle service will be removed as time permits; and no further notification will be sent to the property owner.

If the applicant or owner applies for restoration of service at the location after the individual line extension and facilities have thus been removed, they will be required to pay in advance an amount equal to the actual removal cost including cost of non-salvageable material plus the estimated replacement cost of the necessary individual line extension and facilities excluding cost of material.

CHARGES

The applicant or owner may retain the Cooperative's individual single-phase line extension and facilities in readiness for service for the ensuing twelve (12) month period by the payment of \$45.00, within thirty (30) days of the date of the notice.

The applicant or owner may retain the Cooperative's individual three-phase line extension and facilities for the ensuing twelve (12) month period by the payment of \$113.24, within thirty (30) days of the date of the notice. The Cooperative shall have the right to remove the transformer and other equipment in cases where service may be idle for several months. Transformers and other equipment so removed shall be replaced without charge when applicant or owner requests service resumed; provided, however, that the idle service charge has been paid.
